SOCIETE GENERALE CORPORATE & INVESTMENT BANKING: A MAJOR PLAYER **FOR PRIVATE PLACEMENTS IN 2012**

Societe Generale Corporate & Investment Banking emerged as a major player on the new Eurodenominated French Private Placement market in 2012.

In the "Euro PP" market, estimated at €3.3 billion on 31st December 2012^[2], nine deals were arranged by Societe Generale Corporate & Investment Banking, enabling companies to raise close to €1.3 billion, giving the bank around 40% market share.

This performance highlights the bank's expertise in innovative financing services for companies and the strength of its relationships with investors, who are actively supporting the development of a booming Euro-denominated Private Placement market. It is also in line with the bank's long-term strategy, with the aim of providing additional services to its clients on capital markets.

With this performance achieved in 2012, Societe Generale Corporate & Investment Banking aims to continue to pursue this effort throughout 2013, further confirming its commitment to the financing of the economy and companies.
