Societe Generale Corporate & Investment Banking further strengthens its coverage dedicated to the corporate clients in France

Societe Generale Corporate & Investment Banking is pleased to announce the appointment of co-heads of Coverage and Investment Banking for France, a newly created position, as well as the appointment of two Senior Bankers in France and a co-head of Equity Capital Markets for France, Belgium and Luxembourg.

Jacques Bitton and Jean-Baptiste Giros have been appointed co-heads of Coverage and Investment Banking for France. These appointments are effective immediately. Based in Paris, they report to Thierry d'Argent, Head of Coverage and Investment Banking.

In this newly created role, Jacques Bitton is solely responsible for managing the Senior Bankers' team which maintains the relationship and the strategic dialogue with their clients. Jacques Bitton

Jacques Bitton has been appointed co-head of Coverage and Investment Banking for France in June 2018. Since end of 2006, he was a Senior Banker in charge of the global relationship for a portfolio of large French corporates. Jacques Bitton joined Societe Generale in 1997 as a Managing Director within the Mergers and Acquisitions department. He was named Deputy Head of Corporate Finance in 1999 and Head of M&A for France in 2000. Before joining Societe Generale, Jacques Bitton held various roles within the Corporate Finance team of BNP Group, between 1987 and 1997. He was successively a Director for Equity Capital Markets, then a Managing Director for the Private Equity department. He then became Managing Director within the Advisory department, in charge of financial engineering, advisory for listed companies and privatizations.

Jacques Bitton has worked on several privatizations, executed M&A transactions and advised large corporates on strategic transactions.

Graduated from Rouen business school, Jacques Bitton also holds two master degrees (DESS), one from Paris Dauphine in Capital Markets and the other from Paris Dauphine university in Tax and Business Law.

Jean-Baptiste Giros

Jean-Baptiste Giros has been appointed Head of Client Relationship Management for France at the end of 2017 and Co-Head of Coverage and Investment Banking for France in June 2018. Previously, he was Co-Head of Equity Capital Markets for France, Belgium and Luxembourg, a position he held since June 2015. Jean-Baptiste joined Societe Generale in 2002 within the General Inspection department where he led several projects and from 2008 co-ran as an Inspecteur Principal.
